Approval of Minutes from Previous Meeting

• Minutes from the January HOA Board meeting were unanimously approved with no changes

Financial Update

- The January financial statements were received and reviewed. For the month of January 2022, the HOA has a net operating loss of \$1412.02 which equates to a positive operating budget variance of \$817.98.
- Year to date, the HOA has a net operating income of \$577.38 and a positive operating budget variance of \$1868.38
- The Residential Assessments Receivable account at the end of January 2022 is \$743.00 represented by 11 accounts (6 of which are under The Green Limited Partnership)
- The balance sheet reflects the following for year to date through January 31, 2022

Total Cash and Investments including accrued interest: \$120,481.82

Operating funds: \$54,754.22 Two CDs totaling \$65,386.63

Reserves for Repair and Replacement are currently underfunded by \$322.40.

Prior Year Owners Equity: \$569.22.

Current and New Business

- The trashcans by the ballfield and basketball courts are in disrepair and need to be replaced. It was suggested that the Board purchase the boards to replace around the metal rings to create a new trashcan as this would be a more cost-effective option and will allow us to keep the design the same. A motion was made and seconded to have the ballfield trashcans repaired by the Board at a cost of materials plus \$100 labor charge.
- Discussion was had about hosting a community food drive in the spring to support the Western Fairfax Christian Ministries Food Pantry. A date was decided for May 15th. The signs will be put out on April 30/May 1st to advertise the event. A list of needed/requested items will be provided with the advertisement/notification. Jennifer will coordinate with the Social Committee on the signs.
- It was proposed and unanimously agreed that the Board move to quarterly meetings as opposed to bimonthly meetings. Additional meetings can be added as required due to community business. Meetings will be held June 14th, September 13th, December, and March dates to be determined.
- It was requested that the community reinstate the block party this summer. Jeff will reach out to the social committee to begin the planning process. It was suggested that the block party be held August 27th as this is

the weekend between the first day of school and Labor Day weekend.
