#### Approval of Minutes from Previous Meeting

• Minutes from the June HOA Board meeting and the July Appeals Hearing were unanimously approved with no changes

## Financial Update

- The June 2023 financial statements were received and reviewed. For the month of June 2023, the HOA has a net operating income of \$1061.67 which equates to a positive operating budget variance of \$492.67.
- Year to date, the HOA has a net operating income of \$6010.67 and a positive operating budget variance of \$5686.67.
- The Residential Assessments Receivable account at the end of June is \$329.00 represented by 2 accounts
- The balance sheet reflects the following for year to date through June 30, 2023 Total Cash and Investments including accrued interest: \$137,930.30
  Operating funds: \$70,684.26
  Two CDs totaling \$66,043.88
  Reserves for Repair and Replacement are fully funded with an excess of over \$8400.
  Prior Year Owners Equity: \$6545.89

## Current and New Business

- Jennifer still needs to reach out to find a surveyor as it was recommended that the Board employ a surveyor to survey the HOA common area/tree save area between our community and Waverly Crossing to ensure the Board is maintaining/responsible for the appropriate tree save area. The Board will obtain costs associated with this survey for consideration at the July meeting
- It was suggested that the Board and the community come together to do a community clean up of the various tree save areas. This will take place in the fall when the tree save area is a bit less dense and after the survey is completed.
- The ARCC still needs to provide the Board with a list of homes with 3+ outstanding violations
- To date we have received enough votes to hold the annual meeting. There are 5 candidates running for 2 open positions.
- The annual meeting will be on August 22<sup>nd</sup> at the Sully Police Station.
- It was suggested that the entire ARCC join the first meeting of the new term to level set for the upcoming year.
