Approval of Minutes from Previous Meeting

• Minutes from the June HOA Board meeting were unanimously approved.

#### Financial Update

- The June 2025 financial statements were received and reviewed. For the month of June 2025, the HOA has a net operating loss of \$1181.35 which equates to a negative operating budget variance of \$2380.10.
- Year to date, the HOA has a net operating loss of \$5533.40 and a negative operating budget variance of \$6701.65.
- The Residential Assessments Receivable account at the end of June is \$785.76. This is an increase of \$5.00 from the previous month.
- The balance sheet reflects the following for year to date through June 30, 2025

Total Cash and Investments including accrued interest: \$94,404.37

Operating funds: \$20,313.59 Two CDs totaling \$72,979.13

Reserves for Repair and Replacement liability is \$72,586.21

Prior Year Owners Equity: \$17,369.25

If necessary, the Board can pull funds from the CD maturing in November to supplement our Operating Funds

#### Current Business

- The Board will follow up with the ARC on the spring/summer walkthrough and newsletter.
- Snow Removal it was suggested that future snow removal contracts include clearing the sidewalks along the townhouses and Eagle Chase (near the fence) as well as the sidewalk near the two entrances.
- The Board will secure an ice cream truck for the first day of school.

#### **New Business**

- Members of the Board for the Mubarik Mosque shared updates with the Board around upcoming community events including a community day to be held on September 7<sup>th</sup>. All are invited to attend.
- CMC sent over a draft budget for FY2026 which includes a \$10.00/house/month increase to a \$75.00 monthly
  assessment. The Board made changes to the proposed budget to maintain the \$65/month assessment for one
  more year. The budget will be balanced by pulling funds from PYOE. It is anticipated that dues will need to
  increase next year.

- A charge of \$1263 for FY25 Federal Est Tax over 4 quarters was noted in the June Statement. Jeffrey will inquire what this is for since HOA doesn't pay income taxes.
- The Board will revisit the ARC membership to ensure it is in alignment with our bylaws
- The annual meeting is being held at a Back-to-School supply drive collection site. Jeffrey will post to the Facebook page(s) to alert neighbors to this event.
- H&H Paving sent a proposal to seal/topcoat the townhouse parking lot. The Board unanimously agreed this would not be pursued.
